The Company adopts **the Stop Work Authority** behavioral and cultural improvement tool: every worker has both the right and the duty to suspend work if they perceive immediate risks to safety or the environment, promptly informing their supervisor. Management ensures that such reports will not lead to any disciplinary measures, thereby promoting a transparent and collaborative environment.

Officine Nicola Galperti e Figlio S.p.A. is committed to protecting the health and safety of all individuals involved in its operations by implementing measures aimed at **eliminating hazards and minimizing workplace risks** to the lowest technically achievable level.

Non-Destructive Testing (NDT)




